

# **MAKE ELECTION REFORM A REALITY**

## ***FULLY FUND THE “HELP AMERICA VOTE ACT”***

Dear Senators:

The Help America Vote Act, which passed with overwhelming bipartisan support, includes a laundry list of reforms that states must implement for federal elections. State and local governments are working on reforms such as improving disability access to the polling place, implementing new provisional balloting procedures, designing, developing and implementing a new statewide voter registration system, training poll workers, and educating voters on new procedures and new equipment.

To help state and local governments pay for these reforms, HAVA authorizes \$3.9 billion over three fiscal years, including over \$600 million for FY05. To date, Congress has generously appropriated \$3 billion between FY03 and FY04. However, the FY 05 appropriations bills currently under consideration contain no funding for the states.

State election officials have acted on a commitment that HAVA would not be an unfunded mandate and proceeded with state planning activities to meet the looming HAVA deadlines. It is now time to honor this commitment to the states and to the American public at large, especially to those citizens historically disenfranchised. Without the full federal funding, states and local governments simply cannot afford to complete implementation of the important reforms that they are now required to make.

In addition, the Election Assistance Commission (EAC), established by HAVA to provide guidance and function as a clearinghouse of information for the states, must receive sufficient federal funding to cover administrative costs for their operational functions and programming. Their FY 05 funding request to Congress was \$20 million. According to their request, \$10 million would be allocated to salaries, administrative expenses and other expenses associated with running a federal agency. The other \$10 million would be allocated to developing updated voting equipment standards, new voting equipment certification processes and a myriad of studies and reports on election administration-related topics as mandated by HAVA.

The EAC has struggled through their first months of existence with very little money. For FY 04, this new agency was only appropriated \$1.2 million. They have been unable to hire staff, and unable to generate the kinds of reports needed by election officials and required by HAVA because they can't afford to begin the process. Additionally, their work with NIST to develop new voting equipment standards has been slow and public statements made about the standards delivery date are always qualified with statements related to adequate funding.

Finally, reports in the media and discussions with congressional staff often reference the likelihood that the federal government will be operating under a continuing resolution (CR) for several months at the close of FY 04. Based on the FY04 appropriation for the EAC, the figure they receive to operate under a CR, estimated at \$500,000, would be too low to accomplish their statutory obligations under HAVA.
